

**RELEASE AND INDEMNIFICATION OF ALL CLAIMS /
ASSUMPTION OF RISK / COVENANT NOT TO SUE**

In consideration of being permitted to observe and/or to participate in any way in any sports, events or other activities conducted under the auspices of Amesbury Sports Park, Inc. **including for example but not limited to** soccer, lacrosse, snow tubing, snowboarding, skiing, summer tubing and OGOing (hereinafter, collectively "EVENTS") or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area requiring special authorization, credentials, or permission to enter or an area to which admission by the general public is restricted or prohibited) EACH OF THE UNDERSIGNED, for himself/herself, and/or his/her personal representative hereby:

1. ACKNOWLEDGES THAT THE EVENTS ARE DANGEROUS AND INVOLVE THE RISK OF SERIOUS INJURY AND/OR DEATH AND/OR PROPERTY DAMAGE AND THAT HE/SHE PARTICIPATES THEREIN VOLUNTARILY AND AT HIS/HER OWN RISK. Each of the undersigned also expressly acknowledges that injuries received may be compounded or increased by NEGLIGENT RESCUE OPERATIONS.
2. RELEASES, DISCHARGES AND COVENANTS NOT TO SUE Amesbury Sports Park, Inc., its employees, any promoter, participants, sanctioning organizations or any subdivision thereof, any persons in any RESTRICTED AREA, sponsors, advertisers, owners and lessees of premises used to conduct the EVENT(S), inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENTS and each of them, their directors, officers, agents and employees (all for the purpose herein referred to as "Releasees") FROM ALL LIABILITY TO THE UNDERSIGNED, his/her personal representatives, assigns, heirs, and next of kin, FOR ANY AND ALL LOSS OR DAMAGE AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO OR DEATH OF THE PERSON OR DAMAGE TO PROPERTY ARISING OUT OF OR RELATED TO THE EVENTS WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES or otherwise.
3. AGREES TO INDEMNIFY AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST they may incur arising out of or related to the EVENTS WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES or otherwise.
4. ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENTS whether caused by the NEGLIGENCE OF THE RELEASEES or otherwise.
5. ACKNOWLEDGES, AGREES AND REPRESENTS that he/she (a) has or will review all signage on the premises and abide by any instructions and warnings contained therein; and (b) has, or will immediately upon entering any RESTRICTED AREAS, and will continuously thereafter, inspect the RESTRICTED AREA which he/she enters and he/she further agrees and warrants that, if at any time, he/she is in or about a RESTRICTED AREA and he/she feels anything to be unsafe he/she will immediately advise the officials of such and will leave the RESTRICTED AREAS and/or refuse to participate in the EVENTS.
6. AGREES to the unrestricted use or publication of any PHOTOGRAPHS, VIDEOS OR OTHER MEDIA in which the undersigned may be included, which are taken of the undersigned while present on Amesbury Sports Park premises or while participating in the EVENTS, whether taken by Amesbury Sports Park personnel or others; and RELEASES, DISCHARGES and COVENANTS NOT TO SUE Amesbury Sports Park from any liability resulting from such use or publication, including without limitation any claim for libel or invasion of privacy.
7. AGREES that this Release and Indemnification of All Claims / Assumption of Risk / Covenant Not to Sue extends to all acts and negligence by the Releasees, INCLUDING NEGLIGENT RESCUE OPERATIONS, and is intended to be as broad and inclusive as is permitted by the law of the State in which the EVENTS are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I HAVE READ THIS RELEASE AND INDEMNIFICATION OF ALL CLAIMS / ASSUMPTION OF RISK / COVENANT NOT TO SUE, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
